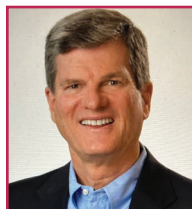

## TMD, Splint Therapy & Airway: Evaluation, Diagnosis & Treatment

The subject of problem solving has a central role of dental medicine. In this course we will explore the cause and effect relationships of dental malocclusions, bruxism, sore muscles of mastication and internal TM Joint derangements. We will also discuss normal TM Joint anatomy, causes and classification of internal derangements and diagnosis using imaging. Based on an accurate diagnosis, we will discuss the appropriate use of various occlusal splints, occlusal equilibration, and joint surgery. We will learn about the critical relationship between airway, breathing and sleep disorders in the etiology of many TMD concerns.

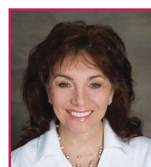

## The Oral Path of Least Resistance: From The Young to The Old

**AM Course:** Will review some of the more common anomalies in the developing dentition. Description, etiology and treatment recommendations that include pre-eruptive intracoronal resorption, molar-incisor hypomineralization, eruption disturbances and anomalies of crown size and shape will be presented.

**PM Course:** Will review ulcerative disease, emphasizing lichen planus, chronic ulcerative stomatitis, aphthous stomatitis, HPV, oropharyngeal cancer and oral cancer. Get ready to laugh, learn and make a difference in the life of your patients.

## Demystifying Digital Dentistry - Implantology

Dental Implantology is a constantly evolving rapidly growing field. New technology is constantly emerging to enhance our workflows while the adaptation and application may be difficult to implement. This presentation will discuss many of the advancements to help provide insights for a restoratively driven prosthetic approach. We will discuss advanced planning, surgical treatment, record collection, and restorative workflows for replacement of a single tooth to full arch FP1, FP2 and FP3 restorations using the most advanced technology. Fully guided and partially guided digital workflows will be explained including a full exploration of techniques and processes that decrease treatment time while increasing predictability and quality of patient care while reducing costs.
