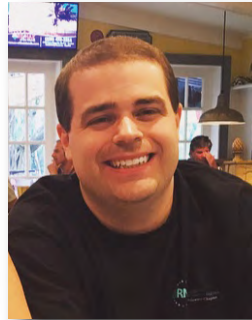

Thanks to an ADA ARC grant, an invitation to the event was extended to non-members for the first time. Fourteen dentists were warmly welcomed along with a few of their team members, and it is hoped some will soon become members of our Society! A collection basket overflowed as participants were encouraged to each bring a youth or adult size toothbrush to replenish the supply for Give Kids a Smile programs.





Tripartite Restructure

In order to be compatible with the ADA's new software platform, Salesforce/Fonteva, the PDA Board of Trustees and the Council of Districts voted unanimously to transition our governance from a quadripartite to a tripartite structure. The districts as governing and dues-collecting entities will be eliminated. The districts will become Trustee Regions, organized geographically within the Commonwealth for the purpose of representation on the PDA Board of Trustees. Before this change, the Second District

(of which we are a part) had one trustee on the PDA Board of Trustees. With this change, the new Second Trustee Region will be permitted three (3) trustees on the Board. At the January 8th meeting of the Dental Society of Chester County & Delaware County, the Board unanimously elected **Dr. James Wolitarsky**, current Second District President Elect, as our Trustee. He will take office in April 2025 at the Pennsylvania Dental Meeting.

Dr James Wolitarsky, Jr. grew up in Wayne and currently resides in Devon with his wife Kimberly and their two children Brooke and Wiliam. After graduating from Hamilton College with a major in psychophysics, Dr. Wolitarsky received his D.D.S. from The University of Oklahoma in 2001. Dr. Wolitarsky then received an A.E.G.D. certificate from The University of Oklahoma in 2002.

Introduction to Forensic Odontology – The roles that dental professionals serve in forensic sciences continue to evolve. Forensic odontology contributes not only to scientific human identification, be it a single individual or a multiple fatality incident and the recognition, evidence preservation and proper documentation of numerous methods and manifestations of abuse. It assists law enforcement with missing persons, cold case investigations, and in matters of litigation citing parameters or standards of dental care. This course provides a comprehensive account of a dental autopsy. The publicly accessible database for missing, unidentified and unclaimed persons will be introduced. This program will educate an attendee as to the mechanisms and appearances of injuries in children and adults. Lessons from the viewpoints of dentistry, pathology and law enforcement will be shared with the mutual objective of the earliest possible intervention and interruption of harm to our patients, friends, and families. *Ms. Riley reports no financial relationships relevant to this presentation.*

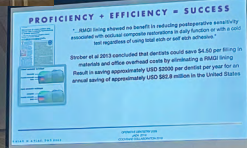

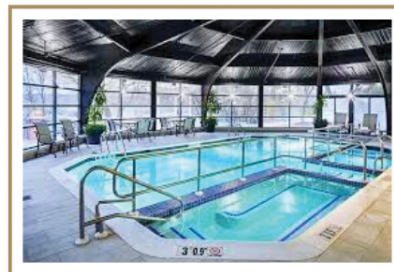

ADA offers guidance on responsible use of technology

The use of artificial and augmented intelligence in dentistry is growing, and with that growth has come an increasing need for guidance to ensure the technology is used responsibly.

“In this era of rapid technological advancement, the need for guidance on the responsible use of AI in dentistry is greater than ever,” said Robert Faiella, D.M.D., chair of ADA Standards Working Group 12.7 on Artificial and Augmented Intelligence in Dentistry. “By embracing established standards and staying informed about evolving best practices, dentists can harness the transformative potential of AI while upholding their ethical and professional obligations to provide safe, effective and equitable care.”



The ADA first published a white paper on AI in dentistry in December 2022, and two more ADA standards publications have followed, including the first U.S. standard on AI in dentistry. Read below about each of the national and international dental standards and guidance documents on AI that have been published or are in development.

ADA White Paper No. 1106:2022, Dentistry — Overview of Augmented and Artificial Intelligence Uses in Dentistry: This white paper introduces the use of artificial and augmented intelligence in many clinical disciplines, including prevention, caries and periodontal disease, implants, oral and maxillofacial surgery, endodontics, prosthetics, and digital imaging. The paper addresses nonclinical areas as well, focusing on payer topics such as claims processing, payment integrity and quality assurance. The document also provides information on the current regulatory environment.

ADA Technical Report No. 1109:2025, Dentistry — Evaluation of Dental Image Analysis Systems Using Augmented Intelligence/Artificial Intelligence: This technical report highlights the need for an independent dataset to validate AI algorithms used to analyze 2D dental images. The dataset, which would be based on known diagnoses from validated sources and kept by a third party that is not an AI manufacturer, would

allow all users, developers and approval agencies to compare each proposed AI algorithm for accuracy and specificity. The report proposes methods for establishing the dataset and describes the general principles of AI, including the need for data and methods to be private and secure to avoid bias.

ANSI/ADA Standard No. 1110-1:2025, Dentistry


— **Validation Dataset Guidance for Image Analysis Systems Using Artificial Intelligence, Part 1: Image Annotation and Data Collection:** The purpose of this standard is to provide standardized criteria for annotating and collecting data from 2D radiographs to classify the images and use them in clinical decision-making. It covers image analysis associated with machine learning and deep learning. The standard identifies the necessary annotations and data content for 2D radiographic images to be queried, exchanged and communicated among providers at all treatment locations for diagnosis, treatment, administrative tasks, research and development efforts. This document is the first U.S. standard on AI in dentistry approved by the American National Standards Institute.

Proposed ISO 18374 Dentistry — Artificial Intelligence (AI) and Augmented Intelligence (AuI) Based 2D Radiograph Analysis — Data Generation, Data Annotation and Data Processing: This document

will define the requirements for developing and documenting the goals, limitations, target end users and target patient population for 2D radiograph analysis software using artificial and augmented intelligence. It will outline the requirements for appropriate reference data, training data, test data, validation data and annotation necessary for the software to ensure it achieves its intended goals. This document is expected to be approved this year. It will be the first international standard on AI in dentistry, and its development involved active participation from the U.S. through the ADA Standards Program.

“Standards and regulatory frameworks are essential in guiding dentists toward responsible AI use,” Dr. Faiella said. “By establishing criteria for safety, efficacy, transparency and fairness, these standards provide a roadmap for evaluating and integrating AI systems into dental practice.”

Summary

- Three Yaomiao-branded children's jewelry sets are being recalled by the Consumer Product Safety Commission. The sets have between three and 12 pieces of jewelry each. The jewelry is silver colored with multicolored gems shaped as a unicorn, butterfly, heart, turtle, star, or rainbow with a cloud. Each set comes packaged individually in small plastic bags inside a lavender box with “A Special Gift for the Charming You” printed on it. “Yaomiao” appears on the box's plastic wrap.
- The recalled jewelry sets contain levels of lead that exceed the federal lead content ban and levels of cadmium that are prohibited in children's products by the Federal Hazardous Substances Act, posing a health hazard to children.
- They were sold exclusively online at Amazon.com from January 2022 through March 2024 for between \$8 and \$21, depending on the set.
- Consumers should immediately stop using the recalled jewelry sets, take them away from children, and contact LordRoads for a full refund. Consumers will be asked to dispose of the recalled jewelry sets and send a photo of the disposed sets to simlordroadple@163.com. LordRoads and Amazon are contacting all known purchasers directly.
- Consider testing children for lead exposure from these and other sources.
